

 - □ All Express Mail and Priority Mail price categories
- New! Padded Flat Rate Envelope
 - □ All Priority Mail price categories
- New! Regional Rate Box*
 - Priority Mail Commercial Base
 - Priority Mail Commercial Plus
- New! Critical Mail*
 - Priority Mail Commercial Plus

Express Mail – Retail Prices

Average Retail Increase – 5.0%

- Starting price (1/2 pound) \$13.25
- Flat Rate Envelope (no change) \$18.30
- New! Legal Flat Rate Envelope

\$18.30



Express Mail – Commercial Base Prices

- Commercial base prices
 - □ No price changes
 - □ Flat Rate Envelope price still \$17.40
 - New! Includes Legal Flat Rate Envelope
 - Approved payment method required





Express Mail – Commercial Plus Prices

Commercial plus prices

New! Minimum volume threshold lowered to 5,000

- □ On average, prices reduced 5%
- Approved payment method required

New! IBI meter now qualifies for Commercial Plus price





Priority Mail – Retail Prices

Average Retail Increase – 3.9%

 All Flat Rate Envelopes 	\$ 4.95
 Small Flat Rate Box 	\$ 5.20
 Medium Flat Rate Box 	\$10.95
 Large Flat Rate Box 	\$14.95
 Large Flat Rate Box APO/FPO/DPO 	\$12.95



Priority Mail — Hold For Pickup Service

- New! Available for online and commercial Priority Mail
 - Excludes Critical Mail
- Hold For Pickup label required
- Intelligent Mail Package Barcode (IMpb) required
- At least one other authorized extra service required





- Average 6.6% lower than Retail prices
- Approved payment method required
- Flat Rate Envelope*
 \$4.75
- Legal and Padded Flat Rate Envelopes \$4.95
- Flat Rate Box prices start at: \$5.00

*Includes Small FRE, Window FRE, and Gift Card FRE



- New! Regional Rate Box
- Affordable shipping for small and dense packages
- Price based on box and zone
 - Regional Rate Box A
 - > 15-pound maximum, starts at \$4.97
 - Regional Rate Box B
 - > 20-pound maximum, starts at \$5.81





Regional Rate Box

- □ USPS-produced packaging required
 - > Top-loading and side-loading boxes for each box category
 - > Boxes must be ordered online at usps.com/shop
- Commercial plus mailers also qualify
- Merchandise Return Service (MRS) parcels also qualify
 - > Returned at Priority Mail prices
- □ Approved payment methods required



- Average 13.6% below Retail prices
 - □ Prices start at \$4.30
- Account volume thresholds apply
 - □ New! Threshold reduced from 100,000 to 75,000
 - > Includes combined total volume of letters, flats and/or parcels
 - □ New! Volume threshold for letters and/or flats 5,000
 - > Excludes Padded Flat Rate Envelope



- Approved payment methods required
 - New! IBI meters now qualify for commercial plus prices
- New! Regional Rate Box also available
 - □ Annual account volume thresholds *do not* apply
 - Postage paid at commercial base prices



- New! Critical Mail
- Attractive offering for entertainment, hospitality, tourism, real estate and membership services
- Travels in automation mailstream
 - Fast, consistent time-in-transit offering
- Free USPS-produced packaging required
 - □ Drives "open first" behavior
 - □ Available only by calling: 1-800-610-8734
- Optional free electronic Delivery Confirmation



Critical Mail requirements

- □ Intelligent Mail Barcode (IMb) required
 - Must only match greatest depth of code achievable from address
- □ Requires mailpiece sample approval
 - > Approved by HQ Shipping Services
- □ 5,000 letters and/or flats annual volume threshold
 - Flat Rate Envelopes qualify (padded FRE excluded)
- □ Approved postage payment methods
 - > PC Postage and Permit Imprint



- Critical Mail Letters \$3.50
 - □ Letters must be automation compatible
 - > 3-ounce weight limit
 - > 1/4 inch maximum thickness
- Critical Mail Flats \$4.25
 - □ Flats must be automation compatible
 - > 13-ounce weight limit for flats
 - > ¾ inch maximum thickness

- Customer commitment agreement required
 - Contact account manager, or HQ Shipping Services

Cana approx



- Price based on cubic measurement and zone
 □ Five price tiers starting at \$4.30
- Approved payment method required
 Permit imprint (with requirements) or PC Postage
- New! Changes to measurement formula
 - Round down each measurement to the nearest ¼ inch
 Dimensions cannot exceed 18 inches in length
- New! Merchandise Return Service now eligible



Cubic measurement formula

- 1. Measure the length, width, and height in inches
- 2. New! Round down each measurement to the nearest $\frac{1}{4}$ inch *Example:* 6 $\frac{1}{8}$ " x 5 $\frac{7}{8}$ " x 6 $\frac{3}{8}$ " is rounded down to 6" x 5 $\frac{3}{4}$ " x 6 $\frac{1}{4}$ "
- 3. Multiply length by width by height and divide by 1728 *Example:* 6" x 5 $\frac{3}{4}$ " x 6 $\frac{1}{4}$ " = 215.6, divided by 1728 = 0.125
 - > Piece exceeds 0.10 Tier 1 maximum threshold
 - It is calculated at Tier 2 (0.101 to 0.20)



Parcel Select

Destination Entry	Average Increase
DDU	8.0%
DSCF	0.2%
DNDC	0.6%
Nondestination Entry	Average Increase
ONDC	9.8%
NDC Presort	7.7%
Barcoded Nonpresort	7.6%



Parcel Select

- Hold For Pickup service
 - New! Limited to barcoded, nonpresorted parcels
- New! Zoned one-pound price
 - Previously the same price across all zones





Parcel Return Service

Average Increase by Category	
Return Network Distribution Center (RNDC)	0.9%
Return Delivery Unit (RDU)	8.0%

- Mailers provide a label to customers for merchandise return
- Permit holder pays postage for returns



New Method For Weight Calculation

- Determining single-piece weight calculations
 - Applicable to:
 - > Express Mail
 - > Priority Mail (except Critical Mail)
 - > Parcel Select
 - > Parcel Post
 - > Bound Printed Matter
 - > Media Mail
 - Library Mail
 - □ Round off weight in decimal pounds to two decimal places
 - > Previously rounded to four decimal places

- Global Express Guaranteed (GXG)
- Express Mail International
- Priority Mail International
- International Priority Airmail (IPA)
- International Surface Air Lift (ISAL)
- Direct Sacks of Printed Matter to One Addressee (M-bags)
- International Extra Services







Global Express Guaranteed (GXG)

Average Overall Increase	Commercial Base Price
3.7%	10% lower than Retail

New! Postage payment by permit indicia

□ Requires use of Global Shipping Software

- IBI meter no longer eligible for commercial base price



Express Mail International

Average Overall Increase	Commercial Base Price
3.1%	8% lower than Retail

- Commercial base prices
 - Express Mail Corporate Account and IBI postage meter no longer eligible
- Flat Rate Envelope (including Legal FRE)
 - □ Only Canada has separate price
- Price groups increase from 10 to 17
- International Return Receipt no longer available



Priority Mail International

Average Overall Increase	Commercial Base Price
3.8%	5% lower than Retail

Commercial base prices for selected destinations

□ IBI postage meter no longer eligible

- Multiple sizes for Flat Rate Envelopes and Boxes
 One price for Canada & Mexico, one price for rest of world
- Price groups increase from 10 to 17



Other International Mail Changes

Product	Average Overall Increase
Airmail M-Bag	5.8%
International Priority Airmail (IPA)	3.3%
No price change for IPA M-Bag	
International Surface Air Lift (ISAL)	6.4%
No price change for ISAL M-Bag	
International Extra Services	7.9%
International Postal Money Orders	
Express Mail International Insurance	
Priority Mail International Insurance	



Other Competitive Products

Competitive P.O. Boxes

- □ New fee group designation C1
- "Baker's dozen" pricing
 - Prices to be published in upcoming Postal Bulletin

Premium Forwarding Service

- □ Overall increase: 5%
- □ Application fee no change
- □ Weekly fee increases to \$14.75

Other Competitive Products

- Address Enhancement Services
 - □ Price increase ranges from 4.2% to 10%
 - > Address Element Correction (AEC)
 - Address Matching System Application Program Interface (AMS API)
 - Topological Integrated Geographic Encoding and Referencing (TIGER/ZIP+4)
